OHSN-REB is qualified through the CTO REB Qualification Program and is registered with the U.S. Department of Health and Human Services (DHHS) Office for Human Research Protection (OHRP).

3. An OHSN-REB member may be qualified for multiple roles, but can only satisfy a maximum of 2 roles per meeting.
4. The OHSN-REB has mandated that all investigators (Qualified Investigators or Co-Investigators) must show proof of TCPS and GCP in order to obtain REB approval for their interventional research project.
