OHSN-REB is qualified through the CTO REB Qualification Program and is registered with the U.S. Department of Health and Human Services (DHHS) Office for Human Research Protection (OHRP).

- 2. All TOH/OHRI staff and physicians must undergo mandatory institutional privacy training which includes annual refreshers.
- 3. An OHSN-REB member may be qualified for multiple roles, but can only satisfy a maximum of 2 roles per meeting.
- 4. The OHSN-REB has mandated that all investigators (Qualified Investigators or Co-Investigators) must show proof of TCPS and GCP in order to obtain REB approval for their interventional research project.
