- 3. An OHSN-REB member may be qualified for multiple roles but can only satisfy a maximum of 2 roles per meeting.
- 4. The OHSN-REB has mandated that all investigators (Qualified Investigators or Co-Investigators) must show proof of TCPS and GCP training in order to obtain REB approval for their interventional research project.
