OHSN-REB is qualified through the CTO REB Qualification Program and is registered with the U.S. Department of Health and Human Services (DHHS) Office for Human Research Protection (OHRP).

**Note:**

1. Members may be asked to attend any of the 3 meeting locations, Civic Campus, General Campus and University of Ottawa Heart Institute to assist with meeting quorum.
2. All TOH/OHRI and UOHI/OHIRC staff and physicians must undergo mandatory institutional privacy training which includes annual refreshers.
3. An OHSN-REB member may be qualified for multiple roles but can only satisfy a maximum of 2 roles per meeting.
4. The OHSN-REB has mandated that all investigators (Qualified Investigators or Co-Investigators) must show proof of TCPS and GCP training in order to obtain REB approval for their interventional research project.
